

RECOMMENDED CONTRACTUAL CLAUSES

I. **EARLY NEUTRAL EVALUATION (ENE)** - In the event of any dispute arising out of or relating to this contract, including its existence, validity or termination, any party hereto may access GlobalMedArb on its web site for the appointment of a Neutral Evaluator under the rules therefore. The Neutral Evaluator shall submit a report within three days after receiving a copy of the contract and position of the parties. No party may submit the dispute for resolution by ENE, for Mediation, Arbitration, or litigation within ten (10) days after final action by the Neutral Evaluator.

IA. **EARLY NEUTRAL EVALUATION/MEDIATION** - In the event of any dispute arising out of or relating to this contract, including its existence, validity or termination, any party hereto may access GlobalMedArb on its web site for the appointment of a Neutral Evaluator under the rules therefor. The Neutral Evaluator shall submit a report within three days after receiving a copy of the contract and position of the parties. In the event that the report of the Neutral Evaluator does not result in an amicable settlement between the parties hereto, within ten (10) days of the latter's report, this matter shall proceed to Mediation under the Mediation Rules of United Nations Commission on International Trade Law, as modified by the Supplemental Rules of Mediation of GlobalMedArb. The number of Mediators shall be _____; the language(s) used in the proceeding shall be _____. No party may submit the dispute for resolution through Arbitration or litigation for a period of thirty (30) days following the initial conference call by the Mediator(s).

IB. **EARLY NEUTRAL EVALUATION/ARBITRATION** - In the event of any dispute arising out of or relating to this contract, including its existence, validity or termination, any party hereto may access GlobalMedArb on its web site for the appointment of a Neutral Evaluator under the rules therefor. The Neutral Evaluator shall submit a report within three days after receiving a copy of the contract and position of the parties. In the event that the report of the Neutral Evaluator does not result in an amicable settlement between the parties hereto, within ten days of the latter's report, the matter shall proceed to Mediation under the Mediation Rules of United Nations Commission on International Trade Law as modified by the Supplemental Rules of Mediation of GlobalMedArb. The parties agree that the number of Mediators shall be _____ and the language(s) used in the proceeding shall be _____. In the event that Mediation does not result in an amicable settlement between the parties hereto within thirty (30) days of the initial conference call by the Mediators(s), this matter shall proceed to Arbitration under the Arbitration Rules of United Nations Commission on International Trade Law, as modified by the Supplemental Rules of Arbitration of GlobalMedArb. The parties agree that the number of arbitrators shall be _____ and the language(s) to be used in the arbitration proceedings shall be _____.

II. MEDIATION - In the event of any dispute arising out of or relating to this contract, including its existence, validity or termination, any party hereto may access GlobalMedArb on its web site for the appointment of Mediator(s) to seek amicable settlement of the dispute between the parties hereto under the Mediation Rules of the United Nations Commission on International Trade Law, as modified by the Supplemental Rules of Mediation of GlobalMedArb. The language(s) of the Mediation shall be _____. No party may submit the dispute for resolution through Arbitration or litigation for a period of thirty (30) days following the initial conference call by the Mediator(s).

IIA. MEDIATION/ARBITRATION - In the event of any dispute arising out of or relating to this contract, including its existence, validity or termination, any party hereto may access GlobalMedArb on its web site for the appointment of _____ Mediator(s) to seek amicable settlement of the dispute between the parties hereto under the Mediation Rules of United Nations Commission on International Trade Law, as modified by the Supplemental Rules of Mediation of GlobalMedArb. The language(s) of the Mediation shall be _____. In the event that the Mediation process does not result in an amicable settlement between the parties hereto within thirty (30) days of the initial conference call by the Mediation(s), this matter shall proceed to Arbitration under the Arbitration Rules of the United Nations Commission on International Trade Law, as modified by the Supplement Rules of Arbitration of GlobalMedArb. The parties agree that the number of arbitrators shall be _____ and the language(s) to be used in the arbitration proceedings shall be _____.

III. **ARBITRATION** - Any dispute arising out of or relating to this contract, including its existence, validity or termination, shall be settled by arbitration in accordance with the Arbitration Rules of the United Nations Commission on International Trade Law, as modified by the Supplemental Rules of Arbitration of GlobalMedArb. The parties agree that the number of arbitrators shall be _____ and the language(s) to be used in the arbitration proceedings shall be _____.

IIIA. **ARBITRATION SUBJECT TO EXPEDITED REVIEW** - Any dispute arising out of or relating to this contract, including its existence, validity or termination, shall be settled by arbitration in accordance with the Arbitration Rules of the United Nations Commission on International Trade Law, as modified by the supplemental Rules of Arbitration of GlobalMedArb. The parties agree that the number of arbitrators shall be _____ and the language(s) to be used in the proceedings shall be _____. Within thirty (30) days following the final ruling of the arbitrator(s), any party may submit a request for review to the Review Board of GlobalMedArb in accordance with its Rules of Expedited Review.
